



## SUSAN G. KOMEN 2026 CENTRAL FLORIDA MORE THAN PINK WALK FUNDRAISING CONTEST

### Official Contest Rules

#### CONTEST

**ELIGIBILITY:** Contest is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen (“Sponsor”) and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries must be submitted in good faith.

Void where prohibited by law. This contest is subject to all applicable federal, state, and local laws.

**HOW TO ENTER:** Contest period begins on March 11, 2026 at 12:01am ET and will end on March 22, 2026 at 11:59pm ET.

When you fully complete the following actions during the Contest period, you are competing with others to win a prize.

When you are registered as a Team Captain for the 2026 Susan G. Komen Central Florida MORE THAN PINK WALK on the event website at [2026 Komen Central Florida MORE THAN PINK WALK](#), you will be automatically considered for this contest.

After the close of the contest period, the Team Captain that registered the most number of Team Members to their Team during the contest period will win a prize.

**PRIZE DESCRIPTION:** Four (4) tickets to the Orlando Storm game on May 3, 2026 held at Inter & Co Stadium in Orlando, Florida. Food, beverages, parking and other amenities not included in prize. Travel to and from Orlando not included in prize. Seats are pre-assigned. Tickets cannot be exchanged for a different date. Tickets are non-transferable, not redeemable for cash, may not be altered in any way, and may not be replaced if lost or stolen. Approximate retail value is \$200.00 USD.

**WINNER SELECTION:** All eligible entries submitted during the Contest period will be considered and the winner is determined by the criteria listed in How to Enter. One (1) winner will be awarded a prize. In the instance of a tie, the tiebreaker will be determined by the winner who registered the most Team Members to their Team first in time. Limit one (1) prize per individual.

**WINNER NOTIFICATION:** The winner will be contacted via the email address or phone number provided in their registration. To claim the prize, the winner must accept the prize within three (3) business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. If a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner based on the next in line under How to Enter. It is within the discretion of Sponsor to select an alternate winner if the prize is unclaimed/forfeited but is not required to do so. Once the prize is claimed, Sponsor will provide the winner’s contact information to representatives of the Orlando Storm within five business days to coordinate redemption of the tickets.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not timely received, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility. Prize cannot be utilized for any promotional, marketing or advertising purpose other than for Susan G. Komen. Prize cannot be "scalped" or used for any illegal purposes.
