



## SUSAN G. KOMEN DMV TRI-STATE MORE THAN PINK WALK

### September 2026 Team Captain Contest

#### Official Contest Rules

**ELIGIBILITY:** Contest is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen ("Sponsor") and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

Void where prohibited by law. This contest is subject to all applicable federal, state, and local laws.

**HOW TO ENTER:** Contest period begins on September 14, 2026 at 12:01 AM ET and will end on September 18, 2026 at 11:59 PM ET.

When you fully complete the following actions during the Contest period, you are competing with others to win a prize.

When you are registered as a Team Captain for the 2026 Komen DMV Tri-State MORE THAN PINK Walk on the event website at [2026 Komen DMV Tri-State More Than Pink Walk](#), and your Team recruits at least five new Team Members who register on the Team page during the Contest period, you will be automatically considered for this contest.

The winners will be determined by the first Five (5) Team Captains that complete the contest.

**PRIZE DESCRIPTION:** Each of the Five (5) Winners will receive one (1) \$50 Gift Card to Safeway. Gift Cards may have expiration dates or excluded items. Approximate retail value: \$50.00 USD.

**WINNER SELECTION:** All eligible entries submitted during the Contest period will be considered and the winners determined by the criteria listed in How to Enter. Five (5) winners will be awarded a prize. In the instance of a tie, the tiebreaker will be determined by the winner who raised the most amount of funds first in time. Limit one (1) prize per individual.

**WINNER NOTIFICATION:** The winners will be contacted by Sponsor via the email address or phone number provided in their registration. To claim the prize, the winners must accept the prize within ten (10) business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. If a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner based on the next in line under How to Enter. It is within the discretion of Sponsor to select an alternate winner if the prize is unclaimed/forfeited but is not required to do so. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, is non-transferable and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility.
