

Official Sweepstakes Rules

Komen Inland Empire Guitar Sweepstakes

NO PURCHASE NECESSARY: No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. This sweepstakes is subject to all applicable federal, state, and local laws.

ELIGIBILITY: Sweepstakes is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen ("Sponsor") and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

HOW TO ENTER: Sweepstakes period begins on April 10, 2023 and will end on November 5, 2023 at 9:59pm PT.

When you fully complete the following actions during the sweepstakes period, you will be entered for a chance to win a prize. When you are registered for the 2023 Susan G. Komen Inland Empire More Than Pink Walk through the event website, Komen Inland Empire More Than Pink Walk and raise \$250 or more during the sweepstakes period through your personal Walk Fundraising page, for every \$250 you raise, you will receive one entry into a drawing for a chance to win a prize.

For alternate means of entry, an individual may send an email to Sponsor and include within the communication the full name of the sweepstakes, the statement "I acknowledge that I have read, understand and agree to the Official Rules," first name, last name, phone number, email address, and home address. Entry must be received no later than November 4, 2023 at 11:59pm PT to be eligible. Alternative entries will receive the maximum number of entries received by a donor entry.

For every \$250 raised, individuals will receive one entry.

PRIZE DESCRIPTION: The prize: One (1) Susan G. Komen custom Fender XX Guitar. Approximate retail value: \$1,500.00 USD.

WINNER SELECTION: All eligible entries submitted during the sweepstakes period will be entered into the drawing on November 8, 2023. One (1) winner will be randomly drawn from all eligible entries. The odds of winning depend on the number of eligible entries received for the sweepstakes. Limit one (1) prize per individual.

WINNER NOTIFICATION: The winner will be contacted via the phone number and/or email address provided to the Sponsor in the winner's entry. To claim the prize, the winner must accept the prize within three (3) business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. If a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. It is within the discretion of Sponsor to select alternate winner if the prize is unclaimed/forfeited but is not required to do so. Once the prize is claimed, the prize will be shipped by Komen via UPS or FedEx to the address provided by winner within 10 business days.

GENERAL TERMS & CONDITIONS: All entrants must meet the eligibility requirements set forth in these Official Rules in order to qualify for the prize. By participating, each entrant agrees to: (1) Abide by these Official Rules and decisions of Sponsor, which shall be final in all respects relating to this sweepstakes; (2) Release, discharge and hold harmless Sponsor, and its respective parents, affiliates, subsidiaries, and advertising and sweepstakes agencies, and the respective officers, directors, shareholders, employees, agents and representatives; and (3) Acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding.

Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that entrant's entry and that entrant may be disqualified from the sweepstakes.

Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not timely received, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility.

If the actual value of a prize is less than previously stated, the difference will not be awarded. Other restrictions may apply. All prizes are subject to change and/or cancellation. Winners must provide Sponsor with an executed IRS form W-9 in order to accept their prize, and may also be required to sign an affidavit of eligibility, liability release, and publicity release. Sponsor reserves the right to request from any entrant additional documentation it reasonably believes is necessary to validate any entry or to award the prize. Without limitation, Sponsor shall not be liable for any failure to deliver prize due to winner's failure to accept delivery, to meet any of his or her obligations hereunder or due to the submission of any false, inaccurate or misleading information.

YOU HEREBY REPRESENT AND WARRANT THAT YOU HAVE READ THESE OFFICIAL RULES AND ARE FULLY FAMILIAR WITH THEIR CONTENTS.
