## Official Rules

When you are registered as a Team Captain for the 2022 Columbus Race for the Cure, and you recruit four (4) team members to Team during the sweepstakes period, you will be entered into a drawing for a chance to win a prize. Note that your individual registration can be changed to Team Captain through the event website.
