

Official Contest Rules

2024 Tampa Bay Registration Contest

NO PURCHASE NECESSARY: No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. This Contest is subject to all applicable federal, state, and local laws.

ELIGIBILITY: Contest is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen ("Sponsor") and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

HOW TO ENTER: Contest period begins on May 6, 2024 and will end on May 17, 2024.

When you fully complete the following actions during the Contest period, you are competing with others to win a prize. Register for the Tampa Bay MTPW and raise a minimum of \$25.

The winner will be determined by online random name generator.

PRIZE DESCRIPTION(S):

The prize(s) include(s) \$50 giftard to Amazon. Approximate retail value \$50 USD.

WINNER SELECTION: All eligible entries submitted during the Contest period will be considered and the winner(s) determined by the criteria listed in How to Enter. One winner(s) will be awarded a prize. In the instance of a tie, the tiebreaker will be determined by online random name generator. Limit one (1) prize per individual.

WINNER NOTIFICATION: The winner will be contacted via the phone number and/or email address provided to the Sponsor in the winner's entry. To claim the prize, the winner must accept the prize within three business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. If a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner based on the next in line under How to Enter. It is within the discretion of Sponsor to select alternate winner if the prize is unclaimed/forfeited but is not required to do so. Once the prize is claimed, the prize will be emailed within 5 business days.

GENERAL TERMS & CONDITIONS: All entrants must meet the eligibility requirements set forth in these Official Rules in order to qualify for the prize. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not timely received, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility.

Without limitation, Sponsor shall not be liable for any failure to deliver prize due to winner's failure to accept delivery, to meet any of his or her obligations hereunder or due to the submission of any false, inaccurate or misleading information.

YOU HEREBY REPRESENT AND WARRANT THAT YOU HAVE READ THESE OFFICIAL RULES AND ARE FULLY FAMILIAR WITH THEIR CONTENTS.
