



Susan G. Komen 2024 New Jersey LAX for the Cure Summer Tournament Contest

Official Contest Rules

CONTEST

ELIGIBILITY: Contest is open to legal residents of the United States who are 18 years of age or older and the parent or legal guardian on behalf of a minor child at the time of entry. Parents or legal guardians agree to these rules along with and on behalf of their minor child. Employees of Susan G. Komen (“Sponsor”) and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

Void where prohibited by law. This contest is subject to all applicable federal, state, and local laws.

HOW TO ENTER: For 2025, 2026 and 2027 Divisions the Contest period begins on March 1, 2024 at 12:01am ET and will end on June 21, 2024 at 11:59pm ET.

For 2028 through 2032 Divisions the Contest period begins on March 1, 2024 at 12:01am ET and will end on June 14, 2024 at 11:59pm ET.

When you fully complete the following actions during the Contest periods, you are competing with others to win a prize.

When you are registered for a Susan G. Komen 2024 New Jersey LAX for the Cure Summer Tournament Event through the event website, you will be automatically considered for this contest. After registration, participants will have access to their individual participant center on [komen.org](https://www.komen.org) which will record their fundraising progress. All donations must be made through their participant page or connected to Facebook Fundraiser to be counted for this Contest. Only checks entered using the event mobile app will be eligible to be counted for this Contest. Cash donations entered using the participant center or mobile app are not eligible/will not be counted to win a prize.

After the close of the contest period, the participants or Teams that raise the most amount of funds in each category listed below during the contest periods will win the prize for that category.

PRIZE DESCRIPTIONS:

Top Fundraising Team Per Division: Each team member will receive One (1) Nike Pink Mini Duffle bag
Approximate retail value \$42.00 USD.

Top Fundraising Player in HS Weekend: One (1) \$2,500 American Express Gift Card. Approximate Retail Value: \$2,500.00 USD.

Top Fundraising Player in Youth Weekend: One (1) \$2,500 American Express Gift Card. Approximate Retail Value: \$2,500.00 USD.

Top Fundraising Player Per Division: One (1) Apple Airpod Max Headphones. Approximate Retail Value: \$549.00 USD.

WINNER SELECTION: All eligible entries submitted during the Contest period will be considered and the winners determined by the criteria listed in How to Enter. Eighteen (18) winners will be awarded a prize. In the instance of a tie, the tiebreaker will be determined by the winner who raised the most donations first in time. Limit one (1) prize per individual.

WINNER NOTIFICATION: The winners will be contacted via the email address or phone number provided in their registration. To claim the prize, the winners must accept the prize within three (3) business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. If a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner based on the next in line under How to Enter. It is within the discretion of Sponsor to select an alternate winner if the prize is unclaimed/forfeited but is not required to do so. Once the prizes are claimed, Sponsor will give the winners contact information to the LAX for the CURE organization who will deliver the prizes to the winners via US mail or email within seven business days. Prizes to winners that are minors will be delivered to their parent or legal guardian.

GENERAL TERMS & CONDITIONS: All entrants must meet the eligibility requirements set forth in these Official Rules in order to qualify for the prize. By participating, each entrant agrees to: (1) Abide by these Official Rules and decisions of Sponsor, which shall be final in all respects relating to this Contest; (2) Release, discharge and hold harmless Sponsor, and its respective parents, affiliates, subsidiaries, and advertising and Contest agencies, and the respective officers, directors, shareholders, employees, agents and representatives; and (3) Acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding.

Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that entrant's entry and that entrant may be disqualified from the Contest.

If for any reason the Contest is not capable of running as planned, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest and select winners from among all eligible entries prior to the cancellation. Persons found tampering with or abusing any aspect of the Contest, or whom Sponsor believes to be causing malfunction or error, disruption or damage will be disqualified. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not timely received, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility.

If the actual value of a prize is less than previously stated, the difference will not be awarded. Other restrictions may apply. All prizes are subject to change and/or cancellation. Winners must provide Sponsor with an executed IRS form W-9 in order to accept their prize, and may also be required to sign an affidavit of eligibility, liability release, and publicity release. Sponsor reserves the right to request from any entrant additional documentation it reasonably believes is necessary to validate any entry or to award the prize. Without limitation, Sponsor shall not be liable for any failure to deliver prize due to winner's failure to accept delivery, to meet any of his or her obligations hereunder or due to the submission of any false, inaccurate or misleading information.
