



2025 SUSAN G. KOMEN GREATER NEW YORK CITY RACE FOR THE CURE

JULY FUNDRAISING CONTEST

Official Contest Rules

ELIGIBILITY: Contest is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen ("Sponsor") and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

Void where prohibited by law. This contest is subject to all applicable federal, state, and local laws.

HOW TO ENTER: Contest period begins on July 21, 2025 at 12:01AM EST and will end on August 1, 2025 at 11:59PM EST.

When you fully complete the following actions during the Contest period, you are competing with others to win a prize.

When you are registered for the Susan G. Komen 2025 Greater New York City Race for the Cure on the event website at [2025 Komen Greater NYC Race for the Cure](#), you will be automatically considered for this contest. After registration, participants will have access to their individual participant center on [komen.org](#) which will record their fundraising progress. All donations must be made through their participant page to be counted for this Contest. Only checks entered using the event mobile app will be eligible to be counted for this Contest. Cash donations entered using the participant center or mobile app are not eligible and will not be counted to win a prize.

After the close of the contest period, the three (3) Individual Participants with the highest number of donations during the contest period will win a prize. Multiple donations by the same individual will be counted as one (1) donor.

PRIZE DESCRIPTIONS:

The Individual Participant with the Highest Number of Donations will receive: One (1) \$150 Gift Card to Tacombi restaurant and One (1) Komen Swag Bag that includes one (1) Komen branded clip-on Bluetooth speaker, one (1) Komen branded cross body bag, and one (1) Komen branded water bottle. Some food and beverage items may not be included with gift card. Gift card may not be redeemable at all restaurant locations. Gift card may have a deadline date to redeem. Approximate retail value: \$190.00 USD.

The Individual Participants with the Second and Third Highest Number of Donations will each receive: One (1) Komen Swag Bag that includes one (1) Komen branded clip-on Bluetooth speaker, one (1) Komen branded cross body bag and one (1) Komen branded water bottle. Approximate retail Value: \$40.00 USD.

WINNER SELECTION: All eligible entries submitted during the Contest period will be considered and the winners determined by the criteria listed in How to Enter. Three (3) winners will be awarded a prize. In

the instance of a tie, the tiebreaker will be determined by the winner who raised the most amount of donations first in time. Limit one (1) prize per individual.

WINNER NOTIFICATION: The winners will be contacted by Sponsor via the email address or phone number provided in their registration. To claim the prize, the winners must accept the prize within ten (10) business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. If a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner based on the next in line under How to Enter. It is within the discretion of Sponsor to select an alternate winner if the prize is unclaimed/forfeited but is not required to do so. Once the prizes are claimed, Sponsor will send the swag bag prizes to the winners via US mail and the gift card via email.

GENERAL TERMS & CONDITIONS: All entrants must meet the eligibility requirements set forth in these Official Rules in order to qualify for the prize. Persons found tampering with or abusing any aspect of the Contest, or whom Sponsor believes to be causing malfunction or error, disruption or damage will be disqualified. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not timely received, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, is non-transferable and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility.

If the actual value of a prize is less than previously stated, the difference will not be awarded. Other restrictions may apply. All prizes are subject to change and/or cancellation. Winners must provide Sponsor with an executed IRS form W-9 in order to accept their prize and may also be required to sign

Without limitation, Sponsor shall not be liable for any failure to deliver prize due to winner's failure to accept delivery, to meet any of his or her obligations hereunder or due to the submission of any false, inaccurate or misleading information.
