



Official Contest Rules

2026 Komen Orange County MORE THAN PINK Walk Sweepstakes

NO PURCHASE NECESSARY: No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. This Contest is subject to all applicable federal, state, and local laws.

ELIGIBILITY: Contest is open to legal residents of United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen ("Sponsor") and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

HOW TO ENTER: Contest period begins on March 9, 2026 at 12:01 AM PST and will end on March 20, 2026 at 11:59 PM PST.

When you fully complete the following actions during the Contest period, you are competing with others to win a prize. When you register for the 2026 Komen Orange County MORE THAN PINK Walk on the event website at 2026 Komen Orange County MORE THAN PINK Walk and send 5 fundraising emails through your participant center during the sweepstakes period, you will be entered into a drawing for a chance to win the prize.

Entries must be complete to be eligible. Limit one entry per individual..

The winner will be determined by random drawing of those individuals that qualify.

PRIZE DESCRIPTION(S):

The prize(s) include(s) one (1) Komen branded water bottle, one (1) Komen branded bucket hat and one (1) Komen branded canvas shopper bag. Approximate retail value \$50 USD.

WINNER SELECTION: All eligible entries submitted during the Contest period will be considered and the winner(s) determined by the criteria listed in How to Enter. One(1) winner(s) will be awarded a prize. In the instance of a tie, the tiebreaker will be determined by first in time to meet criteria in How to Enter. Limit one (1) prize per individual.

WINNER NOTIFICATION: The winner will be contacted via the phone number and/or email address provided to the Sponsor in the winner's entry. To claim the prize, the winner must accept the prize within five(5) business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. If a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner based on the next in line under How to Enter. It is within the discretion of Sponsor to select alternate winner if the prize is unclaimed/forfeited but is not required to do so. Once the prize is claimed, the prize will be delivered via mail or email within ten(10) days.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not timely received, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility.

If the actual value of a prize is less than previously stated, the difference will not be awarded. Other restrictions may apply. All prizes are subject to change and/or cancellation.
