



## Official Rules

### KOMEN SOUTHERN NEVADA MORE THAN PINK WALK SWEEPSTAKES

**NO PURCHASE NECESSARY:** No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. This sweepstakes is subject to all applicable federal, state, and local laws.

**ELIGIBILITY:** Sweepstakes is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen (“Sponsor”) and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

**HOW TO ENTER:** Sweepstakes period begins on December 1, 2025 at 12:01 pm PST and will end on January 31, 2026 at 11:59 pm PST.

When you fully complete the following actions during the sweepstakes period, you will be entered for a chance to win a prize.

When you register for the 2026 Komen Southern Nevada MORE THAN PINK Walk on the event website at [2026 Komen Southern Nevada MORE THAN PINK WALK](#) for every \$50 you fundraise or self-donate on your Komen personal fundraising page during the sweepstakes period, you will receive one (1) entry into a random drawing for a chance to win the prize. All donations are final and non-refundable.

For alternate means of entry, an individual may send an email to Sponsor and include within the communication the full name of the sweepstakes, the statement “I acknowledge that I have read, understand and agree to the Official Rules,” first name, last name, phone number, email address, and home address. Limit one alternate means of entry per individual. Entry must be received no later than January 31, 2026, at 11:59 pm PST to be eligible. An alternative entry will receive the number of entries equal to the highest individual number of entries.

Entries must be complete to be eligible.

**PRIZE DESCRIPTION:** One (1) winner will receive one (1) OKAI Pink Ceetle Pro e-Scooter. Approximate prize retail value: \$750.00 USD.

**WINNER SELECTION:** All eligible entries submitted during the sweepstakes period will be entered into the drawing on January 31, 2026. One (1) winner will be randomly drawn from all eligible entries. The odds of winning depend on the number of eligible entries received for the sweepstakes. Limit one (1) prize per individual.

**WINNER NOTIFICATION:** The winner will be contacted via the email address provided to Sponsor in the winner’s entry. To claim the prize, the winners must accept the prize within 5 (5) business days after the first notification by Sponsor and coordinate pick up or delivery of the prize within ten (10) business days. If the winner fails to timely claim the prize by the deadline, declines the prize, or fails to comply with these official rules, then the winner will be disqualified from receiving the prize. Subject to Sponsor’s sole discretion, if the winning entry cannot be definitively identified as a single individual, then that winning entry is disqualified. In the event there is a dispute regarding the winner’s identity, the prize will be awarded to the individual named on the donation. If a potential winner is disqualified for any reason,

or the prize is unclaimed, Sponsor may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries and the winner selected will have twenty-four (24) hours to claim the prize. If after (3) alternate drawings a winner is not determined, Sponsor reserves the right to select a winner or not award the prize. Pick up/delivery locations subject to Sponsor's approval and, unless agreed to by Sponsor in writing, must be within ten (10) miles of the 2026 Komen Southern Nevada MORE THAN PINK Walk site location.

**GENERAL TERMS & CONDITIONS:** All entrants must meet the eligibility requirements set forth in these Official Rules in order to qualify for the prize. Persons found tampering with or abusing any aspect of the sweepstakes, or whom Sponsor believes to be causing malfunction or error, disruption or damage will be disqualified. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not timely received, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility. Prize cannot be utilized for any promotional, marketing or advertising purpose other than for Susan G. Komen. Prize cannot be "scalped" or used for any illegal purposes.

If the actual value of a prize is less than previously stated, the difference will not be awarded. Other restrictions may apply. All prizes are subject to change and/or cancellation. Winners must provide Sponsor with an executed IRS form W-9 in order to accept their prize, and may also be required to sign an affidavit of eligibility, liability release, and publicity release. An IRS Form 1099 for the approximate retail value of the prize will be filed and a copy provided to each winner. Each winner must provide Sponsor with his or her social security number so that the Form 1099 can be provided. All applicable federal, state, local and other taxes and fees associated with the prize and expenses not stated related to acceptance and use of a prize are solely the responsibility of the winner.

Sponsor reserves the right to request from any entrant additional documentation it reasonably believes is necessary to validate any entry or to award the prize. Without limitation, Sponsor shall not be liable for any failure to deliver prize due to winner's failure to accept delivery, to meet any of his or her obligations hereunder or due to the submission of any false, inaccurate or misleading information.

YOU HEREBY WAIVE ALL RIGHTS AND RELEASE EACH OF THE RELEASED PARTIES FROM ANY CLAIM OR CAUSE OF ACTION, WHETHER NOW KNOWN OR UNKNOWN, OF ANY KIND, INCLUDING BUT NOT LIMITED TO DEFAMATION, INVASION OF RIGHT TO PRIVACY, PUBLICITY OR PERSONALITY OR ANY SIMILAR MATTER, RELATING TO THE SWEEPSTAKES, THE OPERATION THEREOF, OR ANY SUBMISSION, OR BASED UPON OR RELATING TO THE USE AND EXPLOITATION OF THE ENTRIES AS CONTEMPLATED HEREIN, OR USE IN SWEEPSTAKES SITE FORM, EITHER INTENTIONALLY OR OTHERWISE. YOU HEREBY REPRESENT AND WARRANT THAT YOU HAVE READ THESE OFFICIAL RULES AND ARE FULLY FAMILIAR WITH THEIR CONTENTS.
