

## SUSAN G. KOMEN 2022 TRIANGLE RACE FOR THE CURE RACE WEEK - THURSDAY SWEEPSTAKES

### Official Rules

**NO PURCHASE NECESSARY:** No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. This sweepstakes is subject to all applicable federal, state, and local laws.

**ELIGIBILITY:** Sweepstakes is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen (“Sponsor”) and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

**HOW TO ENTER:** Sweepstakes period is April 28, 2022 at 12:01am EST – April 28, 2022 at 11:59pm EST.

When you are registered for the Susan G. Komen 2022 Triangle Race for the Cure, through the event website, [www.komen.org/trianglerace](http://www.komen.org/trianglerace), for every \$25 you raise online during the sweepstakes period, you will be entered into a drawing for a chance to win the prize.

For alternate means of entry, an individual may send an email to Sponsor at [kburrows@komen.org](mailto:kburrows@komen.org) and include within the email the name of the sweepstakes, the name of the drawing under “How to Enter,” the statement “I acknowledge that I have read, understand and agree to the Official Rules,” first name, last name, phone number and a valid email address. Entry must be received no later than April 27, 2022 at 11:59pm EST, to be valid. Alternative entries will receive the maximum entries received by a donor entry.

Entries must be complete to be eligible. For every \$25 raised, individuals will receive one (1) entry.

**PRIZE DESCRIPTION:** One (1) winner will receive One (1) \$68 Gift Card for two “pick your project” at Board and Brush located in Apex, NC and One (1) \$50 Gift Card to Drive Shack located in Raleigh, NC. The total retail value of the prize package is \$118 USD.

**WINNER SELECTION:** All eligible entries submitted during the sweepstakes period will be entered into the drawing on April 29, 2022. One (1) winner will be randomly drawn from all eligible entries. Odds of winning depend on the number of eligible entries received for the sweepstakes.

**WINNER NOTIFICATION:** The winner will be announced on April 29, 2022 and will be contacted via the phone number and/or email address provided to the Sponsor in the winner’s race registration. To claim the prize, the winner must accept the prize within three business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. In the event that a potential winner is disqualified for any reason, Sponsors will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. Once the prize is claimed, Sponsor will deliver the prize to the winner within ten business days.

**GENERAL TERMS & CONDITIONS:** All entrants must meet the eligibility requirements set forth in these Official Rules in order to qualify for the prize. By participating, each entrant agrees to:

- (1) Abide by these Official Rules and decisions of Sponsor, which shall be final in all respects relating to this sweepstakes;

Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize cannot be resold, traded, or auctioned and has no cash redemption equivalent.

If the actual value of a prize is less than previously stated, the difference will not be awarded. Other restrictions may apply. All prizes are subject to change and/or cancellation. An IRS Form 1099 for the fair market value of the prize will be filed and a copy provided to each winner. Each winner must provide Sponsor with his or her social security number so that the Form 1099 can be provided. Without limitation, Sponsor shall not be liable for any failure to deliver prize due to winner's failure to accept delivery, to meet any of his or her obligations hereunder or due to the submission of any false, inaccurate or misleading information.
