Official Rules

NO PURCHASE NECESSARY: No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. This sweepstakes is subject to all applicable federal, state, and local laws.

HOW TO ENTER: Sweepstakes period is April 27, 2022 at 12:01am EST – April 27, 2022 at 11:59pm EST.

When you are registered for the Susan G. Komen 2022 Triangle Race for the Cure, through the event website, <u>www.komen.org/trianglerace</u> for every two (2) donations you receive online during the sweepstakes period, you will be entered into a drawing for a chance to win the prize.

For alternate means of entry, an individual may send an email to Sponsor at <u>kburrows@komen.org</u> and include within the email the name of the sweepstakes, the name of the drawing under "How to Enter," the statement "I acknowledge that I have read, understand and agree to the Official Rules," first name, last name, phone number and a valid email address. Entry must be received no later than April 27,2022 at 11:59pm EST, to be valid. Alternative entries will receive the maximum entries received by a donor entry.

Entries must be complete to be eligible. For every two donations received, individuals will receive one (1) entry.
