# SUSAN G. KOMEN TRIANGLE RACE FOR THE CURE TEAM CAPTAIN FUNDRAISER SWEEPSTAKES

#### **Official Rules**

**NO PURCHASE NECESSARY:** No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. This sweepstakes is subject to all applicable federal, state, and local laws.

For alternate means of entry, an individual may send an email to Sponsor at <a href="mailto:kburrows@komen.org">kburrows@komen.org</a> and include within the email the name of the sweepstakes, the name of the drawing under "How to Enter," the statement "I acknowledge that I have read, understand and agree to the Official Rules," first name, last name, phone number and a valid email address. Entry must be received no later than May 1, 2022 at 11:59pm EST, to be valid.

Entries must be complete to be eligible. Limit one entry per individual per drawing.

# **PRIZE DESCRIPTION:**

Two (2) winners will each receive one (1) Axes and Ales one hour party tour at Axes and Ales in Raleigh, NC. Must be able to provide valid ID confirming age 21 or older. Retail Value of Each Prize: \$270.00 USD

**WINNER SELECTION**: All eligible entries submitted during the sweepstakes period will be entered into the drawing on May 2, 2022. Two (2) winners will be randomly drawn from all eligible entries. Odds of winning depend on the number of eligible entries received for the sweepstakes.
