### SUSAN G. KOMEN TRIANGLE RACE FOR THE CURE TOP FUNDRAISER SWEEPSTAKES

#### Official Rules

**NO PURCHASE NECESSARY:** No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. This sweepstakes is subject to all applicable federal, state, and local laws.

Entry must be received no later than May 1, 2022 at 11:59pm EST, to be valid.

Entries must be complete to be eligible. Limit one entry per individual per drawing.
