Official Contest Rules

CONTEST

ELIGIBILITY: Contest is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen (“Sponsor”) and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

Void where prohibited by law. This contest is subject to all applicable federal, state, and local laws.

HOW TO ENTER: Contest period begins on February 19, 2024 at 12:01am ET and will end on February 25, 2024 at 11:59pm ET.

When you fully complete the following actions during the Contest period, you are competing with others to win a prize.

When you are registered for the Susan G. Komen 2024 West Palm Beach MORE THAN PINK WALK on the event website at [Komen 2024 West Palm Beach MORE THAN PINK Walk](#), you will be automatically considered for this contest. After registration, participants will have access to their individual participant center on komen.org which will record their fundraising progress. All donations must be made through their participant page or connected to Facebook Fundraiser to be counted for this Contest. Only checks entered using the event mobile app will be eligible to be counted for this Contest. Cash donations entered using the participant center or mobile app are not eligible/will not be counted to win a prize.

After the close of the contest period, the participant that raised the most amount of funds during the contest period will win the first-place prize. The participant that raises the second most amount of funds will win the second-place prize.

PRIZE DESCRIPTIONS:

Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility.
