Official Contest Rules

CONTEST

ELIGIBILITY: Contest is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen ("Sponsor") and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

Void where prohibited by law. This contest is subject to all applicable federal, state, and local laws.

HOW TO ENTER: Contest period begins on December 5, 2025 at 12:01am ET and will end on December 14, 2025 at 11:59pm ET.

When you fully complete the following actions during the Contest period, you are competing with others to win a prize.

When you are registered for the Susan G. Komen 2026 West Palm Beach MORE THAN PINK WALK on the event website at [2026 Komen West Palm Beach MORE THAN PINK Walk](#) you will be automatically considered for this contest. After registration, participants will have access to their individual participant center on komen.org which will record their fundraising progress. All donations must be made through their participant page to be counted for this Contest. Only checks entered using the event mobile app will be eligible to be counted for this Contest. Cash donations entered using the participant center or mobile app are not eligible and will not be counted to win a prize.

After the close of the contest period, the Individual Participant that raised the most amount of funds during the contest period will win a prize.

PRIZE DESCRIPTION: One (1) Certificate for a Two (2) night stay at the Eden Roc Miami Beach Hotel, in Miami Florida, for one (1) room in the Deluxe Room Category. Food, beverages, valet parking and other amenities not included in prize. Travel to and from hotel not included in prize. Certificate valid 12/15/2025 through 12/15/2026. Certificate is not valid on holidays and blackout dates may apply. Subject to availability. Certificate is non-transferable, not redeemable for cash, may not be altered in any way, and may not be replaced if lost or stolen. A Credit Card may be required for check in. WINNER SELECTION: All eligible entries submitted during the Contest period will be considered and the winner is determined by the criteria listed in How to Enter. One winner will be awarded a prize. In the instance of a tie, the tiebreaker will be determined by the winner who raised the most donations first in time. Limit one (1) prize per individual.

WINNER NOTIFICATION: The winner will be contacted via the email address or phone number provided in their registration. To claim the prize, the winner must accept the prize within three (3) business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. If a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner based on the next in line under How to Enter. It is within the discretion of Sponsor to select an

alternate winner if the prize is unclaimed/forfeited but is not required to do so. Once the prize is claimed, the prize will be emailed to the winner within seven business days.

Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility.
